Facility Visitation Rules

- 1. All visits are monitored and recorded.
- 2. Inmates are normally permitted two (2) non-contact visits per week in accordance with the established schedule. Visits may be twenty (20) minutes in duration.
- 3. Visitation schedules will be strictly adhered to. All visits are on a "first come, first served" basis.
- 4. You must arrive 30 minutes prior to your scheduled visit and show your valid, government-issued, photo ID. Anyone who arrives late or does not have a valid, government-issued photo ID will not be allowed to visit.
- 5. **No items** are to be brought into the visitation center other than your car keys. All items should be secured in your vehicle (purses, wallets, cell phones, etc.)
- 6. Only two (2) visitors are allowed to visit at one time.
- 7. Children under the age of 17 must be accompanied and under the direct supervision of an adult.

8. DRESS CODE:

- a. Clothing that is tight-fitting or revealing is prohibited.
- b. No article of clothing may be worn which depicts language, pictures, or drawings that may be considered profane or offensive by current public standards.
- c. Shirt and shoes are mandatory
- d. Shirts only shirts with sleeves (long or short) may be worn. No undershirts, sleeveless shirts, open midriff, see-through or fish net tops will be allowed (male or female).
- e. No shorts or cut-offs. This applies to all ages.
- f. Slacks/pants shall be worn at or above the waist. Females may wear Capri pants as long as they are no shorter than three (3) inches below the middle of the knee.
- g. Females (all ages) may wear dresses or skirts with a hemline no shorter than three (3) inches above the knee when standing.
- h. Any questions concerning this will be directed to the supervisor on duty.

9. **DENIAL OR TERMINATION OF VISIT:**

- a. Visitor under the influence of alcohol or drugs.
- b. Visitor refuses or fails to prevent their children from disturbing other persons in the visiting area.
- c. Visitor displays inappropriate activity or affection.
- d. Visitor's conduct or condition deemed by the shift supervisor to be disruptive to visiting operations, or to security and good order.
- e. Any violation to the above or facility rules. This may cause denial of any future visits.

10. **SPECIAL VISITS:**

- a. Must be pre-approved by the Security Lieutenant at least seven (7) days prior to the visit.
- b. Visitors traveling more than 200 miles one way.
- c. Considered on a case-by-case basis.

VISITATION IS A <u>PRIVILEGE</u> WHICH MAY BE REMOVED BY THE ACTION OF A DISCIPLINARY BOARD IF THE INMATE OR HIS VISITOR(S) FAILS TO COMPLY WITH THE RULES OF VISITATION AND/OR THE RULES OF THE FACILITY.
